### Tamila Tasheva

Tamila Tasheva is a co-founder and coordinator of the “CrimeaSOS” public organization (<http://krymsos.com/en/about/krym-sos>). Tamila is a Crimean Tatar, whose family came back to Crimea in the early 90s. In 2007 she moved to Kyiv where she continued to promote interests of the Crimean Tatars as an officer of the Parliamentary Committee for education and science and as a producer for Crimean Tatar musicians in Kyiv. She also has a great experience in public relation sphere and was a political and media consultant.



### Alexandru Musteata

Alexandru Musteata is a civil society activist in the Republic of Moldova. For the last 4 years he has been coordinating the Good Governance Program at Soros Foundation-Moldova, providing support for anti-corruption initiatives launched by civil society organizations in Moldova. Starting this year, Alexandru is managing a new project that aims to develop Civil Society Organization in the Autonomous Territorial Unit of Gagauzia in the southern Moldova.



### Maria Symonova

Maria is a manager of the Clean Universities anti-corruption campaign and a working group coordinator of the EaP CSF UNP. Maria is a member of the expert pool of the Black Sea NGO Forum. Maria Symonova graduated from the Odessa National Maritime University and previously was working as a communication manager of the Ukrainian National Platform of Civil Society Forum Eastern Partnership.



### Jacek Wojciechowicz

Economist and manager. A Polish and Australian national. Since 2012 a Project Director and the Chief Ethics Officer to the PKP Group (The Polish State Railways), in charge of the relationship with the World Bank and other IFIs. Strategic advisor to the President of PKP S.A. Involved in preparation of Safety and Security Strategy and restructuring of the PKP Group. As the Chief Ethics Officer responsible for the supervision of the ethics program. A former senior official of the World Bank (1996-2009). A former Deputy CEO of Springvale Community Health Centre, Australia. Expert of the European Commission in the area of innovation. Consultant of the World Bank (innovations, transport and development projects). Consultant on Health Care Reform. Chief Advisor to the German-Polish-Ukrainian Society. Expert in Industry Restructuring Programs.

## **Marieluise Beck**

A member since 1980, Marieluise Beck is amongst the founding members of the German Green Party. In 1983, she was elected to serve as Member of the German Bundestag. After serving as a Member of Parliament of the Free Hanseatic City of Bremen from 1991 to 1994, Ms. Beck was re-elected to the German Bundestag in 1994 and has been a Member ever since.

From November 1998 to 2005, Marieluise Beck served as Federal Government Commissioner for Migration, Refugees and Integration and Parliamentary State Secretary in the Federal Ministry for Family Affairs, Senior Citizens, Women and Youth. Since November 2005, Ms. Beck has served on the Committee on Foreign Affairs of the German Bundestag in which she currently functions as spokesperson on eastern European affairs for the Green parliamentary group. She holds positions as chairperson of the German-Bosnian Parliamentary Friendship Group and is a member of the German-Ukrainian and German-South Caucasus Parliamentary Friendship Group. In addition, Marieluise Beck is a Member of the Parliamentary Assemblies of the Council of Europe and the OSCE.



## **Mustafa Nayyem**

Mustafa Nayyem is a Ukrainian Member of Parliament and initiator of GoGlobal Project. Formerly he was a reporter for the newspaper "Kommersant Ukraine", the TVi channel, and the internet newspaper Ukrayinska Pravda. In 2014, he took part in special elections to Verkhovna Rada of Ukraine. Now Mustafa Nayyem is a member of political party Democratic Alliance. He is a member of the Committee on issues of European Integration.



## **H.E. Ambassador Roman Waschuk**

H.E. Roman Waschuk, ethnic Ukrainian, Canadian diplomat, Ambassador of Canada to Ukraine. He studied history focusing on the Central and Eastern Europe and received his MA degree from the University of Toronto in 1985.. In 1987 he began his career in the diplomatic service of the Ministry of Foreign Affairs of Canada. He was first posted as a second secretary for politics in the Canadian Embassy in Moscow.

Then he subsequently served as Political Counsellor in Kyiv in 1994-1998 and Minister-Counsellor for politics and economy in Berlin. Between 1991-1994 he worked on East European affairs in the Department of Foreign Affairs, Trade and Development of Canada. Since 2011 Waschuk has served as Ambassador to Serbia, with cross-accreditation to the Republic of Macedonia and Montenegro. He served there until September 2014. Since October 2014 he has been the Ambassador of Canada to Ukraine.
