Roman Waschuk



Roman Waschuk (BA [History], University of Toronto, 1983; MA [History], University of Toronto, 1985) began his career with External Affairs Canada in 1988. First posted as Second Secretary (Political) in Moscow, he subsequently served as Counsellor (Political) in Kyiv and Counsellor (Political) and Minister-Counsellor (Political/Economic) in Berlin. In Ottawa, Mr. Waschuk’s postings have included Deputy Director of the European Union Division, Deputy Director of the Policy Planning Division, Director of the Global Partnership for Biological Non-Proliferation, Chemical Weapons Destruction and Redirection of Former Weapons Scientists Division, and Director of the Stabilization and Reconstruction Programs Division. In 2011-2014, Mr. Waschuk served as Ambassador to Serbia, with concurrent accreditation to Montenegro and Macedonia. Since 2014 Mr. Roman Waschuk has been serving as Ambassador Extraordinary and Plenipotentiary of Canada to Ukraine.

Annika Weidemann



Dr Annika Weidemann is the Deputy Head of the European Union Delegation to Ukraine since September 2018. Dr Weidemann studied law in Kiel, Germany, and St. Petersburg, Russia. She also holds a Master degree in Public Administration from the Kennedy School of Government at Harvard University in the United States of America. Her PhD is in the field of international law and international relations. Before coming to Ukraine, she was a member of the Iran Task Force of the European Union's External Action Service (EEAS). In that capacity, she worked directly with the Secretary-General of the EEAS and was in charge of overseeing implementation of the nuclear deal with Iran, the Joint Comprehensive Plan of Action.

Andreas Umland, CertTransl (Leipzig), AM (Stanford), MPhil (Oxford), DipPolSci, DrPhil (FU Berlin), PhD (Cambridge) held fellow- or lectureships at the Hoover Institution, Harvard University, St. Antony's College, Urals State University, Shevchenko University of Kyiv, Catholic University of Eichstaett, and Kyiv-Mohyla Academy. Since 2014, he has been Senior Research Fellow at the Institute for Euro-Atlantic Cooperation, Kyiv. He is the general editor of the book series Soviet and Post-Soviet Politics and Society and an editor of the web journal *Forum noveishei vostochnoevropayskoi istorii i kul'tury*. He is a member of the boards of directors/editors of the International Association for Comparative Fascist Studies, NGO "Kyiv Dialogue", book series Explorations of the Far Right, Fascism: Journal of Comparative Fascist Studies, Journal of Soviet and Post-Soviet Politics and Society, and The Ideology and Politics Journal.

Mykhailo Zhernakov



Mykhailo Zhernakov (born in 1985) is a Ukrainian lawyer, co-founder and the director of DEJURE Foundation, lead expert on judicial reform and a Board member of Reanimation Package of Reforms (RPR), the biggest reform-oriented civil society coalition in Ukraine. Former judge of Vinnytsia District administrative court (2012-2015). Joined RPR as an independent expert in early March 2014 after the Revolution of Dignity. Resigned from the position of a judge in Feb, 2015 to work full-time on judicial reform. Studied Law in Kharkiv, Ukraine. Ph.D. in Law (Kyiv, 2009), LL.M. (Bologna, 2010), Dr. Habil. (Kyiv, 2016). Took direct part in the development of Ukraine's judicial reform, was one of the advocates for the renewal of the judiciary, creation of the new Supreme Court in Ukraine and the active participation of the civil society in it. Member of a Public integrity council, a civic body responsible for integrity checks of judges.
